## **Schedule 3 List of Bodies with DPOs**

For the purposes of section 6(1)(f) of the Regulation of Lobbying Act 2015 (No. 5 of 2015) 62 public bodies will be classified as containing public service positions which are to be considered as Designated Public Officials ("DPO").

(1) These Regulations may be cited as the Regulation of Lobbying Act 2015 (Designated Public Officials) Regulations 2024.

(2) These Regulations shall come into operation on 1 January 2025.

A public servant in a position specified in column (3) of the table in Schedule 3 in the public service body specified in column (2) there of opposite the reference number for that public service body in column (1) thereof is prescribed as a designated public official for the purposes of section 6(1)(f) of the Regulation of Lobbying Act 2015 (No. 5 of 2015).
